## OVERVIEW

Antigua and Barbuda launched its Citizenship by Investment Programme in 2013 and has since built a reputation for being the most flexible programme in the Caribbean for family applicants. It is the only Caribbean CBI programme that includes university-enrolled children up to age 30 in the base application cost — a meaningful saving for families with older children in higher education.

## INVESTMENT ROUTES

### National Development Fund (NDF)

**USD 230,000 (family of up to 5) / USD 100,000 (single applicant)**

A non-refundable contribution to the National Development Fund. The family rate of \$230,000 covers up to five family members — making this one of the most cost-effective...

### Approved Real Estate

**USD 300,000 (shared) / USD 400,000 (sole ownership)**

Purchase in an approved resort or development. Minimum five-year holding period.

### Business Investment

**USD 1,500,000 (sole investor) / USD 400,000 per investor (joint)**

Direct investment in a qualifying Antiguan business, creating at least three jobs for local nationals. Subject to Cabinet approval.

- Only 5 days total residency required over 5 years
- University graduate children up to age 30 eligible
- Dual citizenship permitted — no need to renounce existing passport

### Family Structure Review

We review all dependants — ages, enrolment status for older children, dependency status of parents — to confirm eligibility and...

### Pre-Submission Review

Compliance check against the Citizenship by Investment Unit's (CIU) standards before submission.

### Approval & Investment

Conditional approval issued. NDF payment made. Full approval confirmed within 30 days of payment.

### Document Compilation

Comprehensive dossier prepared for each applicant and dependant: passports, birth certificates, marriage certificates, police...

### Application Submission

Full application submitted to the Antigua & Barbuda CIU. Acknowledgement typically received within 30 days.

**6**

### Certificate & Passport

Citizenship certificates and passports issued for all family members. Secure courier delivery — no visit required.
