OVERVIEW

Grenada's Citizenship by Investment Programme was established under the Grenada Citizenship by Investment Act and has operated since 2013. It has earned a distinctive reputation in the investment migration space for one specific reason: Grenada is the only Caribbean country with a treaty investor (E-2) visa arrangement with the United States.

 The GCIB reviews your application. Processing takes approximately 4–6 months. We track status and respond to any requests for...
- 6 Investment & Certificate**
 On conditional approval, the investment payment is made. The citizenship certificate and passport are issued within 4–8 weeks of...
